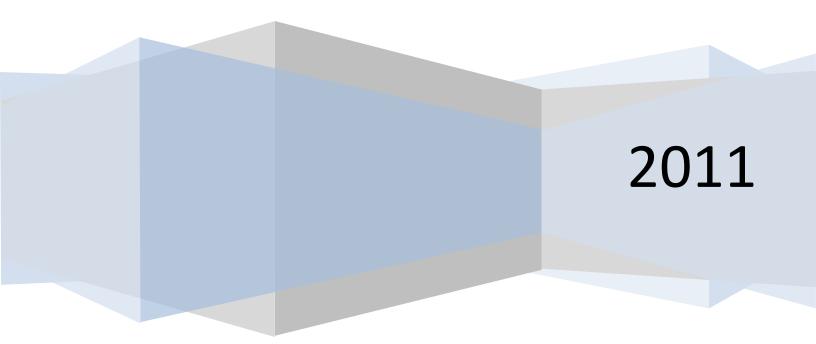

### Welcome Letter from the President

Dear members, students and executives,

Wow, has two years flown by! It seems that only yesterday I was standing up in front of 60 presidents pitching the dream of CABS. Now, it has been two years and some considerable achievements later where we stand today. In this letter, I will address the state of CABS today, as well as our failures and successes of the past year.

Let me first begin by thanking my full executive with whom nothing would be possible. As a remote and national organization, the trust needed amongst the executive was paramount to achieve anything. Our team was not without hiccups (no great team is), however we pushed through all adversities and made sure we kept our members as our number one priority.

#### **Failures**

Unfortunately, CABS has not delivered on a few promises this year. I would like to highlight a few of these and try to describe the environment in which our failures occurred.

#### 1. Incorporation

This is something many of our members had asked for. At present, we have not completed our national not-for-profit incorporation. At our last update, I had described how we hired a non-profit specific lawyer to assist our process. After review, they prepared a document highlighting what would be needed to make our constitution Industry Canada suitable. In short, we needed to completely change and rewrite our constitutional structure. As an option, our lawyer informed us that Industry Canada is releasing a new Not-For-Profit act, which may allow our constitution to be passed as it currently stands. **Action:** my executive voted to have me prepare a fully compliant version of our constitution for presentation to our members. Attached to this package is that version for your consideration.

#### 2. Alumni Database

Our electronic prowess took a step back this year. In my first term, we focused on the electronic infrastructure. This year, we focused on a more collaborative approach that ensures sustainability of our properties and those we are guardians of. Needless to say, there has been very little progress towards an alumni database except a few test platforms. **Action:** This is something I encourage the next executive to approach with vigour.

#### 3. Various behind the scene initiatives

Not giving too much away, CABS worked diligently all year exploring new options and services which might help our membership. As an executive and society, we focus on ensuring our executive members are perfectly prepared for their jobs. While a few of these projects came very close to fruition,



ultimately they failed. **Action:** My team is preparing transition information to make sure that if future executives wish to take on these endeavours, the work is reduced.

#### Successes

Now, with the missteps out of the way, I would like highlight some of the teams' great progress.

#### 1. JDCW

In August 2010, after months of preparation and challenges, CABS pitched for the Guardianship of JDCW. A competing bid placed by JDCW alumni was also tendered. While there were preliminary negotiations of a collaborative bid, it took strong feedback and an 11<sup>th</sup> hour "perspective" session to create a combined vision for the future of JDCW. Pitched and accepted on the Sunday of WBSC, CABS officially became the guardian of JDCW. What CABS is really proud of is how we believe each stakeholder is correctly respected and our members have a voice in the future of the competition. I would like to personally thank all those involved in the massive challenge in providing the future of JDCW.

#### **2. JDCC**

JDCC was held for the second time at Wilfrid Laurier University. Co-Chairs Evan Thor and Heather Mitchell along with their team held amazing games and truly solidified the JDC spirit in Central Canada. This year's focus, from a CABS perspective, was ensuring the sustainability of the conference and ironing out the details (see constitution). Darryl Moyers spent countless hours crafting and implementing policy and ways to ensure CABS' role was clearly defined. Another emphasis of JDCC was to ensure a bid for 2012 was tendered. After significant deliberation by the Eastern Presidents, Carleton University stepped up and placed a bid for JDC Central 2012 – good luck to the team. Finally, CABS prepared a franchise document entitled: "The JDC Central Bible", to ensure that future OC's have all the resources they need to organize and execute this very complex event.

#### 3. RoundTable Bids

One of the mandates of the CABS pitch for RoundTable Guardianship in March of 2010 was ensuring the quality of bids moving forward. We are extremely pleased that two universities have expressed interest in hosting RT 2012. We would like to offer our support to both the Edwards School of Business and The University of New Brunswick in their pitches. Finally, CABS has implemented transition packages, past budgets and a review of presentation materials to ensure quality bids are presented to the membership.

#### 4. Drop Box

The loss of old documents and past knowledge is astounding. No recent records of the CBSC ever survived their demise. With this in mind, as well as our national reach, we have implemented an internal cloud based file system. Next year's executive will find everything we have created, available at a moment's notice.



#### 5. Transition

I believe a strong transition to next year is of the utmost importance to ensure the sustainability of CABS. Therefore, we have prepared and are continuing to prepare transition documents, clean emails and one-on-ones.

#### 6. Elections and Solicitation

As of writing, we have candidates for all positions for next year's executives. We as a team are extremely excited with the candidates and the quality of said candidates. I would have liked to see multiple names for every position. Moving forward, this should prove easier as only 4 executives will turnover each year.

#### 7. Financial policy and sustainability

We are ending our term with a strong financial position, with solid financial policy and records.

8. Increased member communication (development sessions / monthly updates)

This year, we implemented stronger recorded monthly updates to members; as well, each VP Member Relations attempted to hold monthly development sessions. This practice is something we hope continues in the future.

#### **The Future of CABS**

I would like to finish with a thought for the future of CABS. As an organization and idea, CABS has grown tremendously in our first two years. However, I believe we have only scratched the surface of what united business students are capable of. I believe CABS will one day represent full time positions working around the clock to ensure Canadian Business Students are the most motivated, organized, educated and developed students in the world. I would like CABS to ensure we are the envy of every nation.

Thank you for reading Wishing all our members continued success and a lifetime of laughter.

### **VP External Update**

Wow, I can hardly believe that a year has gone by already. With RoundTable one week away, it's sad to see my time as a CABS Executive come to an end but it's been a great year and I am excited to pass on our work to a very strong group of election candidates.

I had the opportunity this year to be the first ever VP External for CABS. I set a list of goals, and as in any position, as you can all now attest to as your mandates come to an end, some goals get realised and some don't. I am happy with the way the VP External role developed and am looking forward to a successful turnover so that my successor may continue the initiatives I may not have had the chance to complete.

#### Accomplishments

One of my main goals was to establish relationships with other organizations to improve CABS services, share best practices and improve the overall awareness of the CABS brand in Canada. As you know, CABS now has a very strong working relationship with RÉFAEC, which includes a written working agreement, regular contact and updates between the organizations as well as standing invitations to each others' conferences. CABS and RÉFAEC share some common goals and are excited for this relationship to continue and grow in the future. Furthermore, CABS has also established communication with the Canadian Federation of Engineering Students (who have a very similar organizational structure and properties as CABS) as well as the Canadian MBA Society.

As the connection between CABS and RÉFAEC as well as the only French speaking Executive on CABS, I wanted to make the organization available to all universities in Canada. Therefore, I enlisted the aid of a translation student and past executive of the CFES (who translated their constitution) to create [unofficial] French translations of the CABS Constitution and By-Laws.

The CABS Year End Awards are new this year and is something I undertook as VP External. Modeled after the awards given by RÉFAEC, I worked to establish the awards to promote collaboration and communication between all of our members. We had an exciting list of nominees and I am looking forward to announcing the winners at the RoundTable Gala next weekend.

Although the elections are still to come, I already consider them to be a success. I moved the awards under the VP External portfolio this year and undertook the coordination of the nominations, the candidates as well as the actual election process. Although there is not as much competition as I would have liked to have seen, I am very happy with the strong candidates that have been presented to you.



### **Items for Succession**

I am already hard at work creating a turnover package for my successor as I strongly believe that an organization such as CABS is only as successful as its succession. I came into this role blind so I want the new VP External to have as easy of a transition as possible.

The Alumni Database was an initiative suggested to me back in the fall. However, due to a lack of time and a shift in priorities, the database did not get much further than a few testing platforms. I do believe this is something that could be a huge asset to the organization and I encourage the next executive to make it (as well as the website construction to host it) a top priority.

Finally, I would still like to explore the possibilities of Five Days for the Homeless coming under CABS guardianship. Although it was looked into, it was not possible this year but I would like to see it explored again next year as both organizations grow and move forward.

When you elected me at a year ago, I was excited for a new challenge but I had no idea what I had gotten myself into. It has been a lot of hard work but being a part of CABS has been an amazing experience that I wouldn't change for anything. I am so proud of everything that our Executive accomplished, as well as everything that our members accomplished this year. Congratulations to everyone and see you in Kelowna!

A full year has gone by since the VP Corporate Relations position was created. During the year, we had an opportunity to begin developing this position and some relationships that can continue and grow in the future.

My goals for the portfolio this year were the following:

- To establish national partnerships that are beneficial for CABS Members through providing discounts on services they frequently use (ex. Travel)
- To develop a set of resources that can used by CABS when reaching out to sponsors
- To ensure partnerships entered into by CABS are not in excess of what CABS requires and to not "compete" with our member for sponsors
- To connect CABS partners with conference OC's and member schools where appropriate
- To adequately prepare my successor through transition planning throughout my term

#### Accomplishments

To this date we are continuing to explore partnership opportunities and deals so we can provide you with opportunities for cost-savings that will be passed off to my successor.

I am anticipating a smooth transition for my successor and am excited that they will be able to "hit the ground running" and focus exclusively on developing strategic partnerships for CABS and its members. As we continue to mature as an organization, this portfolio will continue to grow and generate exciting opportunities.

#### **Areas for Improvement**

One of the biggest obstacles we faced this year was the inability to share your contact information with potential sponsors who were interested in working with you. In order to remedy this for the upcoming



year, we are providing each President and VP Corporate Relations a consent form that allows us to provide information to interested sponsors. Please ensure that you provide us with this completed sheet at Roundtable.

I'd like to congratulate you all for your accomplishments over the year. Give yourselves a pat on the back for all your hard work. I'm very thankful to have had an opportunity to meet many of you over the two years I have been involved with CABS as a member and as an executive. ### **VP Finance Update**

It was a fairly eventful year for the second and final term as VP Finance for the Canadian Association of Business Students. With extensive expansion this year, especially into the west, CABS had a lot more cash flow than it did in prior year. We experienced growing pains as a larger society financially when the realizations came that the controls and reporting systems originally assigned were not adequate for a society of eight people. Financial controls and policies over expense reporting, late fees, no paying schools, creation and removal of the TTS Financial Structure were all put in place to compensate for the ever-growing interest in the Canadian Association of Business Students.

Things we accomplished this year regarding implementation of new financial policies are:

- 1. Pre-approving large expenses,
- 2. The inefficiencies in the current TTS Financial Structure,
- 3. No-payment policy,
- 4. Late payment penalty and,
- 5. Expense policies regarding transportation.

The purpose of these policies and controls that have been implemented over my two years as VP Finance were to protect member's financial interest in CABS. Without the interest of our members our operations would be severely compromised.

The largest challenge we faced this year was managing our travel expenses. Since our expansion into the west, the travel became more expensive. With our two largest conferences approaching (RT and NSBC) we had to budget very conservatively in order to ensure we didn't run a deficit budget to leave our successors with. As illustrated by the financial reports, we were successful, and have managed to leave a nice surplus for the incoming executive. We were able to achieve this by choosing to send fewer executives to conferences where they weren't needed as well as booking flights in advance.

Thank you for a great two years and I look forward to watching where the society grows from here!

#### **4. JDCC:**

A second successful year for JDCC! 400+ Eastern Canadian business students gathered from 8 universities and REFAEC to compete at Wilfrid Laurier University. Hosted by Evan Thor and Heather Mitchell JDCC saw Dalhousie and Brock expand their delegations while adding the Richard Ivey School of Business (Can I see your I-V?). Mark Featherstonhaugh and Christine Jackson will host JDCC 2012 at Carleton University and have plans on expanding the competition further. Rumour has it that we may even see delegations from Guelph and Windsor!

- 5. Other accomplishments:
- **McGill Constitution:** Celine and the team at McGill worked hard to revamp their corporate structure and implement a new constitution. Springing the plan on me at April REFAEC, Celine leveraged CABS to source constitutions from other societies and began the tedious task of restructuring the MUS. The new constitution was voted in and will take effect for the 2011/2012 executive.
- **GTL:** Guelph, Laurier and Ryerson have found the ability to merge societies to form Greater Toronto Love (GTL). These three schools have attended each other's events year-long and even hosted joint events. I hope to see this collaboration continue and new collaborations formed among other schools!
- UNB Levy: I still haven't had the opportunity to meet Bob Keleher, President of the UNB Business Administration Undergraduate Society (Biz Soc), in person. Yet, I feel like I know Bob very well! Bob's presence was felt at every monthly meeting. Always a strong contributor, Bob desired to learn as much as possible about other societies which could be used to increase the profile of the UNB Biz Soc and the value it provides members. With the help of CABS, Bob's executive was able put its first levy in place of \$100.00 per student, increasing its budget to \$100,000 annually! The Biz Soc previously operated on a budget of ~\$2,000 annually (not including sponsorship) generated through memberships sold to students for \$10 each.

While I'm sad to leave CABS after working with Justin to start the organization two years ago, I'm thrilled by its growth and the friends I have met. I wish all of you the best on your future endeavours and hope you continue to remain involved in your school community in some capacity as well as the overall community of the Canadian Association of Business Students as Alumni.

#### 1. A toast to JDC Central 2011...

- To Co-Chairs Evan Thor and Heather Mitchell, their amazing OC, and their extremely successful execution of JDC Central;
- To The School of Business & Economics at Wilfrid Laurier University and the bustling metropolis (Mennonite buggies included) of Waterloo, Ontario;

- To an effective bidding process and acclamation vote facilitated under the *new* JDC Central Constitution;

### VP Conferences & Competitions West Update

#### Dear Members,

Wow! What a wild ride this year has been. It seems like only yesterday that Justin and Kevin were telling me about CABS and why I should join this executive, and now my year long term is coming to a close. I have not only made some great friends on this executive and with you, our members, but I have also learned so much from the political environment this position throws you into!

I will touch on a few key items that I have been working on, as well as add in transition points which I would like to see future executives take on.

#### 1. JDC West & the Competition Council (JDCWCC)

In the summer, there was a whirl wind of activity out west in regards to the competition which every school in the region holds so dear – JDC West. CABS arrived at the Western Business School Conference (WBSC, previously August Meeting) at the Edwards School of Business ready to pitch a strong bid for ownership against the JDC West Alumni group as many months of group collaboration went nowhere. However, after both groups pitched a little side conversation turned into a last minute collaboration and shocking presentation the next day. Needless to say, I think everyone was happy. The collaboration put CABS as the "guardian"- the definition of that being the group which will step in and handle JDC West should the competition board dissolve or become reckless.

After speaking with the JDC West lawyer about the new "act" passed, she informed us that legally the word guardian doesn't really exist. I then decided to write up a brief contract stating the arrangement between the JDCWCC and CABS. This is to be signed next week by both parties. The current structure of the JDCWCC is quite strong with 6 alumni positions with voting rights and 1 alumni position without. This is in addition to the 1 non-voting position for the CABS VP Conferences and Competitions West and the 1 voting position for the current year's JDC West Co-Chair external. This position is currently held by Nathan Petersen of the University of Alberta.

The council has been implementing some strong guidelines and will be going "full steam ahead" as well enter into JDCWLS in Edmonton at the end of the month. The council is trying to have all of them there, at Nathan's invitation, to show a strong front and to have a strong transition for the JDC West captains this year.

#### 2. RoundTable

As everyone knows, RoundTable has had to go through a few speed bumps along the way this year. However, Dustyn and his team made it over them and have designed an amazing conference full of new and exciting twists that really places RoundTable above and beyond a normal business conference. It was great to have the support of the CUS at UBC and between their points and mine in meetings; a strong sense of unity was really achieved. I'm so proud of this year's organizing committee and they all



deserve a good day off after this weekend!!

There are two great bids which are secured for 2012. All of my best wishes go out to the University of New Brunswick and the Edward's School of Business. The winner of this process will be announced at the Saturday night gala at RoundTable 2011. As we speak, a transition checklist is being created (with deadlines) for the 2011 OC, so that the 2012 OC can be fully informed on the good, bad and amazing of the previous year's work. #### 3. JDC & JDC West & The Pan Canada Question

This year, I had the privilege of attending two of the three JDC competitions this year. Jeux du Commerce or "Le Jeux" as it is lovingly referred to out east, was an eye-opening experience!
